

Nutcracker Commitment Letter

CONGRATULATIONS on being selected to perform in the Nutcracker of Parker! Your commitment guarantees the success of the production. If you are unable to fulfill the commitment, please submit a written notification to the office as soon as possible.

COST (Non-Refundable)

Fee covers costumes, costume cleaning, rehearsal time, production sets, and props.

\$150 for company members* Due August 30

(Dancers registered for Youth, Junior, Intermediate, & Senior Companies)

*Company members pay lower fee because they pay monthly tuition fee.

\$180 for non-company members. Due August 30

(Gingersnaps, Baby Mice, Party Children, Bakers or dancers in one role)

Principal Roles (Clara, Dew Drop, Snow Queen, Sugar Plum Fairy)

Costumes are provided for Principal Roles. Dancers may rent or purchase their own tutu at own expense. **Dancers with the part of Clara/and or Sugar Plum pay additional fees for rehearsals.**

REHEARSAL ATTENDANCE POLICY

1. Choreography Rehearsals (dancers learn choreography): Attendance MANDATORY
2. Costume Fittings: Costume Fittings are MANDATORY
3. Studio Rehearsals (dances cleaned): **(2) EXCUSED ABSENCES*** permitted
(This does not apply to Gingersnaps or Party Children.)
4. All Cast Rehearsals (dances rehearsed in context of scene) **(1) EXCUSED ABSENCE*** permitted
5. Theater Rehearsals: Attendance is MANDATORY
Dancers who miss dress rehearsals will not be able to perform.

EXCUSED ABSENCE – Please submit all known absences in writing. Email (ballet@coloradoschoolofdance.com) **one week in advance** to excuse absence. Notify the teacher by e-mail **and** call the front desk if absence is due to sickness.

UNEXCUSED ABSENCE – Not Permitted. Failure to provide notification of absence results in probation. Any future violation of the attendance policy will result in the removal of the dancer from their assigned part.

Understudy Requirements and Policies

An understudy does not pay a participation fee unless they fill the role they are understudying. Please sign the commitment letter now as we consider you an important member of the Nutcracker production.

THE NUTCRACKER OF PARKER COSTUME CONTRACT

- A) Costumes are checked out and checked in at the Photo Shoot, Dress Rehearsals & Performances. **No costumes are taken home.** Participation Fee covers costume rentals, alterations, and cleaning. If any costume is damaged, parent will be charged a replacement cost (estimated at \$150-200.)
- B) Costume(s) with excessive makeup stains, food or drink stains, or that are heavily soiled will be charged a cleaning fee of \$30.00 per costume. Perspiration stains are taken into account as normal wear on a costume.
- C) Dancers are required to provide their own nude camisole leotards, shoes, tights, earrings, and makeup for the performances, dress rehearsals, and Pictures. Refer to the Accessory Requirement list for each specific part. Please plan ahead as certain items must be special ordered. All shoes should be clean with no holes. Pointe Dancers are charged \$5 if ribbons come undone or ribbon knot shows on stage.
- D) Costume(s) and accessory pieces must be put back on the designated rack or in the designated storage bin after each performance. Failure to do so will result in one warning and then a pick-up fine of \$10.00 every-time thereafter. Younger children will have assistance backstage.
